BizBuySell, a national business opportunity website stated in their Insight Report on 10/26/17 that small business transactions in the US reached a record high in the 3rd quarter of 2017 from data statistics reported by business brokers nationwide.

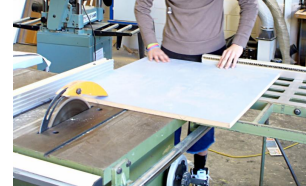
